



## Notification of Semayai Sub District administrative organization.

On Expression of Willingness to Commit to Integrity and Transparency in Administration of State Affairs

In accordance with spirit of the Constitution of the Kingdom of Thailand B.E. ๒๕๖๐ (๒๐๑๗), The Official Information Act B.E.๒๕๔๐ (๑๙๙๗), The Royal Decree on Criteria and Procedures for Good Governance B.E.๒๕๔๖ (๒๐๐๓), National Anti-Corruption Strategy Phase ๓ (B.E. ๒๕๖๐ - ๒๕๖๔) (๒๐๑๗ - ๒๐๒๑), and the Policy Statement of the Council of Ministers Delivered by General Prayut Chan-o-cha, Prime Minister, to the National Legislative Assembly in B.E. ๒๕๕๗ (๒๐๑๔), No.๑๐ Promoting Administration of State Affairs that Upholds Good Governance and Prevents and Suppresses Corruption and Malfeasance in the Public Sector by using legal measures, the inculcation of values, morals, ethics and conscientiousness in preserving the dignity of a civil servant, and honesty, coupled with efficient public sector management, to strictly safeguard against and combat corruption and malfeasance by government officials at all levels as well as raising the capacity of government agencies to become efficient and accountable in order to proactively provide services in response to the need of people and improve the Integrity and Transparency Assessment (ITA) of the Semayai Sub District administrative organization.

In this regard, the Director-General of the Department of Local Administration, as the top executive position of organization, has officially issued the Notification of the Semayai Sub District administrative organization. on Expression of Willingness to Commit to Integrity and Transparency in Administration of State Affairs. This Notification will be applied as guidelines, standards, and values for government officials and employees of the Department of Local Administration to abide by, along with other pertaining rules, regulations, and orders. To successfully achieve the mission of the organization with transparency, morality, and integrity without corruption, the Semayai Sub District administrative organization has established the principles for its internal agencies as follows:


๑. Administering state affairs and performing duties according to the principle of good governance by providing public services with responsiveness, efficiency, transparency and equity.
๒. Inculcating values and positive attitudes among public officials and employees in accordance with the aforementioned concepts, as well as applying the Philosophy of Sufficiency Economy to their work and daily lives.
๓. Conducting procurement process and promoting operational procedure with transparency in every step and allowing private sector, civil society, and the public to engage in scrutinizing all the administrative work by disclosing all relevant information.

๔. Promoting Damrongdhama Center of Sub District administrative organization as a tool for people to notify information or make comments concerning corruption.

๕. Seriously investigating corruption cases and imposing maximum punishment upon officials or employees convinced of corruption.
